SUBJECT: Determining a Benefit Requestor's Legal Name

Purpose

U.S. Citizenship and Immigration Services (USCIS) is updating policy guidance in the <u>USCIS</u> <u>Policy Manual</u> to address how officers determine a benefit requestor's legal name.

Background

As part of the adjudication of immigration benefit requests, USCIS reviews evidence, including biographical and biometrics information submitted by the benefit requestor, as well as DHS systems, to verify identifying information, including the requestor's name. Prior guidance in determining a legal name did not address common law names assumed through usage, or other situations USCIS encounters when adjudicating benefit requests such as variations in name order and individuals who use mononyms (that is, a one-word name). USCIS is now updating its guidance to address such scenarios.

This guidance, contained in Volume 1, Volume 11, and Volume 12 of the Policy Manual, is effective immediately and applies prospectively to applications filed or pending on or after the publication date. The guidance contained in the Policy Manual is controlling and supersedes any related prior guidance.

Policy Highlights

• Expands upon guidance on how USCIS determines a legal name for purposes of adjudication and issuance of secure identity documents with the requestor's legal name, including addressing common law names, name order, and mononyms.
