Second Quarter 2024 | Managed Accounts

Portfolio Review

The Small Cap Core portfolio underperformed the Russell 2000 Index in the second quarter. Poor stock selection and an overweight in industrials and poor stock selection in financials detracted from performance. Good stock selection and an underweight in health care and good stock selection in information technology contributed positively to performance.

The biggest contributors to performance during the quarter were EMCOR Group and FTI Consulting.

- EMCOR continues to generate strong financial results in a healthy demand environment driven by datacenter, high-tech manufacturing, energy efficiency, health care, and reshoring projects. Revenues and Remaining Performance Obligation growth continue to move higher, while favorable project mix and operational excellence resulted in margins ahead of target.
- In the latest quarter, FTI Consulting reported healthy revenue growth across all business segments with commensurate margin improvement.
- Other top contributors included Toro, Clearwater Analytics, and Moelis & Co.

The biggest detractors from performance during the quarter were Simpson Manufacturing and Graco.

- Simpson Manufacturing's shares lagged following the company's reports of lower-than-expected operating results primarily driven by greater-than-expected allowances for volume discounts that reflect a continued market share shift to larger homebuilders—a shift that should serve the company well in the long-term due to its strong relationships with most national homebuilders.
- Graco's underperformance in the quarter was due to declining revenue across all business segments and nearly all regions as general macro-economic conditions provided a softer operating environment for the company.
- Other bottom contributors included Watts Water Technologies, Kadant, and Primerica.

Purchases and Sales

During the quarter, there were no new purchases or complete sales from the portfolio.

Outlook

It is always important to remember that no one can predict the macroeconomic environment with any regular accuracy. That is especially true right now. That said, until the Federal Reserve's most recent hiking cycle, the U.S. economy enjoyed 13 years of rates averaging 0.5%. This supported asset prices and made it easier for businesses, regardless of quality, to be successful. While we expect the Federal Reserve to eventually cut interest rates, we do not expect interest rates to return to 0%. Assuming interest rates settle at around 3-4%, that could have a profound impact on how companies operate and how assets are priced. We believe rates at this level may allow for quality companies with low leverage to better differentiate themselves to investors. Competitively advantaged businesses typically are better positioned to weather a more capital constrained environment.

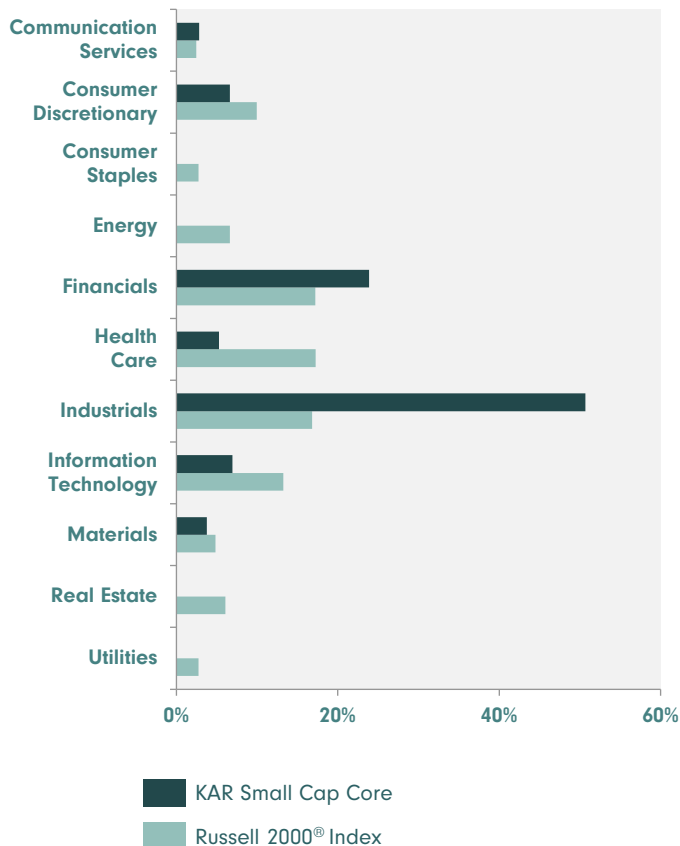

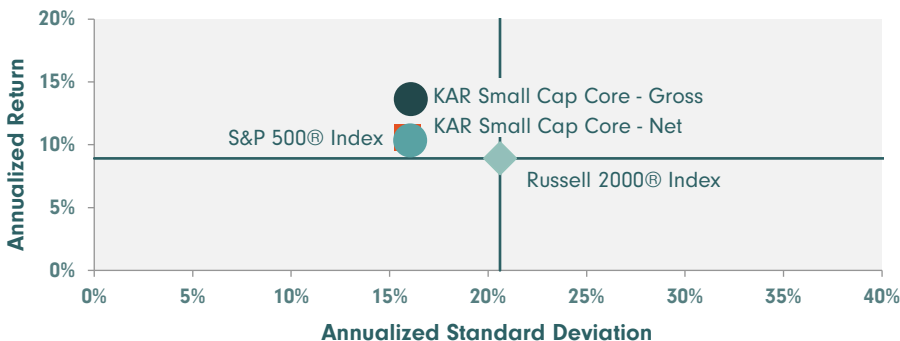

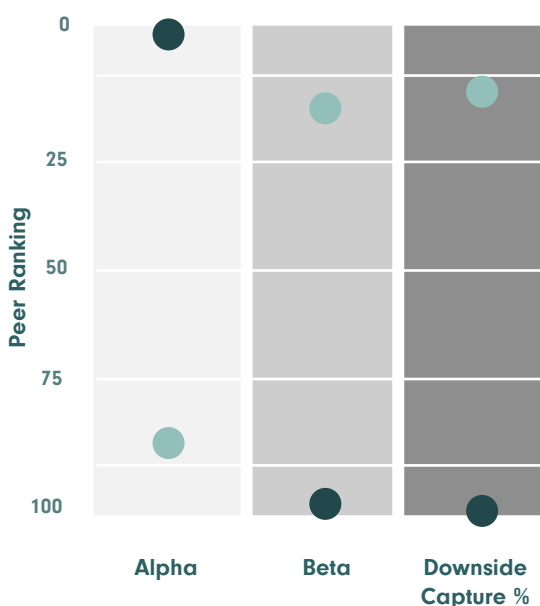

Small Cap Core Wrap Portfolios are invested in equity securities with market capitalizations consistent with the Russell 2000® Index, that have market control, rising free cash flow, shareholder-oriented management, strong consistent profit growth and low-debt balance sheets. For comparison purposes, the composite is measured against the Russell 2000® Index. The Russell 2000® Index is a market capitalization-weighted index of the 2,000 smallest companies in the Russell Universe, which comprises the 3,000 largest U.S. companies. The index is calculated on a total-return basis with dividends reinvested. Benchmark returns are not covered by the report of the independent verifiers. The inception date of the composite is April 1992. The composite was created in October 1995. Policies for valuing investments, calculating performance, and preparing GIPS Reports are available upon request. The firm's list of composite descriptions, list of broad distribution pooled fund and the list of limited distribution pooled funds descriptions are available upon request.

Beginning on January 1, 2006, sub-advisory wrap fee portfolios are also included in composite results. Each sub-advisory relationship is included in the

composite as one account. All portfolios included in this composite for all periods are wrap portfolios.

The standard wrap fee schedule in effect is 3.00% on total assets. Actual management fees charged may vary depending on applicable fee schedules and portfolio size, among other things. GLOSSARY

Standard Deviation: Measures variability of returns around the average return for an investment portfolio. Higher standard deviation suggests greater risk. **Alpha:** A risk-adjusted measure of an investment's excess return relative to a benchmark. **Sharpe Ratio:** A risk-adjusted measure calculated using standard deviation and excess return to determine reward per unit of risk. **Information Ratio:** The information ratio (IR) is a measurement of portfolio returns beyond the returns of a benchmark, usually an index, compared to the volatility of those returns. **Beta:** A quantitative measure of the volatility, or systematic risk, of a security or a portfolio in comparison to the market as a whole. **Downside Capture Ratio:** A statistical measure of an investment manager's overall performance in down-markets. It is used to evaluate how well an investment manager performed relative to an index during periods when that index has dropped.

Tracking Error: The divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark. It is reported as a standard deviation percentage difference, which reports the difference between the return an investor receives and that of the benchmark they were attempting to imitate.

INDEX DEFINITION

The Russell 2000® Index is a market capitalization-weighted index of the 2,000 smallest companies in the Russell Universe, which comprises the 3,000 largest U.S. companies. The index is calculated on a total return basis with dividends reinvested. The index is unmanaged, its returns do not reflect any fees, expenses, or sales charges, and is not available for direct investment.
